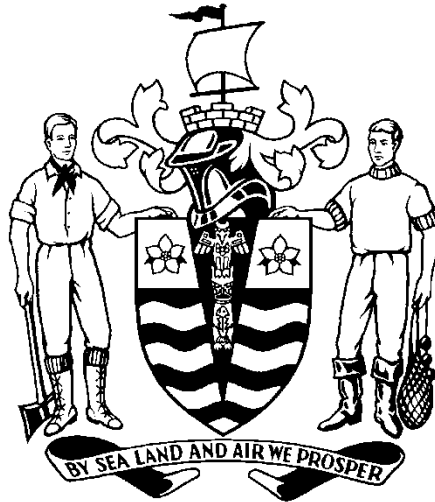

BY-LAW NO. 9360

A By-law to designate enforcement of certain by-law offences by ticket

**[Consolidated for convenience only,
amended to include By-law No. 14446
effective September 16, 2025]**

THE COUNCIL OF THE CITY OF VANCOUVER, in public meeting, enacts as follows:

SECTION 1 INTERPRETATION

Name of By-law

1.1 The name of this By-law, for citation, is the "Ticket Offences By-law".

Definitions

1.2 In this By-law:

"Chief Licence Inspector" means the person appointed by Council from time to time as Chief Licence Inspector for the city, and includes any officer, official, or employee acting on behalf of or in place of the Chief Licence Inspector and any property use inspector or other person authorized by Council or the Chief Licence Inspector to enforce by-laws;

"City Engineer" means the person appointed by Council from time to time as City Engineer for the city, and includes any officer, official, or employee acting on behalf of or in place of the City Engineer and any street use inspector, engineering technician, survey assistant or other person authorized by Council or the City Engineer to enforce by-laws;

"Environmental Protection Officer" means a person employed by the City in that role, or otherwise appointed to that role by Council.

"Fire Chief" means the person appointed as such by Council pursuant to the Vancouver Charter, every Deputy Fire Chief, and every *member* authorized in writing to act on behalf of the Fire Chief.

"Manager, Property Use Inspections" means a person employed by the City in that role, or otherwise appointed to that role by Council, and includes all persons employed as property use inspectors;

"Manager, Urban Landscape Development" means all persons employed by the City in the capacity of Manager, Urban Landscape Development and includes any person whose employment involves the enforcement of the Protection of Trees By-law or the protection of trees within the City;

"Medical Health Officer" means the person appointed by Council from time to time as Medical Health Officer for the city, and includes any officer, official, or employee acting on behalf of or in place of the Medical Health Officer and any environmental health inspector or other person authorized by Council, Vancouver Coastal Health Authority, or the Medical Health Officer to enforce by-laws;

"Police Officer" means a peace officer or constable as provided under the *Police Act*, and employed by the Vancouver Police Board;

"Poundkeeper" means the person appointed by Council from time to time as the Manager of Animal Control for the city, and includes any officer, official, or employee acting on behalf of or in place of the Poundkeeper and any animal control officer or other person authorized by Council or the Poundkeeper to enforce by-laws; and

"tables" means every table set out in this By-law following section 2.6.

Table of contents

- 1.3 The table of contents for this By-law is for convenient reference only, and is not for assistance in interpreting or enforcing this By-law.

Severability

- 1.4 A decision by a court that any part of this By-law is illegal, void, or unenforceable severs that part from this By-law, and is not to affect the balance of this By-law.

SECTION 2 REGULATION OF TICKET OFFENCES

Designation of by-laws

- 2.1 For the purpose of section 482.1(1)(a) of the Vancouver Charter, Council designates the by-laws named in the titles to each of the tables.

Designation of by-law enforcement officers

- 2.2 For the purpose of section 482.1(1)(b) of the Vancouver Charter, Council designates the persons listed in Column 1 of each of the tables as by-law enforcement officers.

Authorization of the use of any word or expression on a ticket

- 2.3 For the purpose of section 482.1(1)(c) of the Vancouver Charter, Council designates the words or expressions listed in Column 2 of each of the tables as words or expressions to describe the offences under the by-law provisions listed in Column 3 opposite each such word or expression in Column 2.

Ticket offence fines

- 2.4 Council sets the fine for contravention of each by-law provision as the amount listed in Column 4 of each of the tables opposite each such provision in Column 3, except where an amount is set out in Column 5 opposite the amount in Column 4, in which case the fine amount is the figure in Column 5, if paid on or before the 30th day after service of the ticket.

Enforcement of ticket offences

- 2.5 A by-law enforcement officer referred to in Column 1 of each of the tables may lay an information by means of a ticket for contravention of a by-law provision listed in Column 3 of the same table.

Existing fines

- 2.6 Despite anything to the contrary in the Animal Control By-law, Health By-law, Licence By-law, Noise Control By-law, Street and Traffic By-law, Drinking Water Conservation By-law, Water Works By-law, Fire By-law, Protection of Trees By-law, Mountain View Cemetery By-law, City Wharf By-law, Graffiti By-law, Standards of Maintenance By-law, Street Vending By-law or Solid Waste By-law, the fine set out in each of those by-laws for contravention of a by-law provision listed in Column 3 of each of the tables does not apply if a by-law enforcement officer lays an information by means of a ticket under this By-law.
