

Section 9

- 9.1 In addition to the requirements of Sections 10 and 11, all signs shall be in compliance with the applicable regulations of the district in which they are or will be located, which regulations are set out in Schedules “A” to “I” inclusive which are attached to and form part of this By-law.
- 9.2 For the purpose of regulating signs pursuant to this By-law the following districts are hereby designated and described by way of the Districts, or parts thereof, established pursuant to the Zoning and Development By-law and which form a constituent part of the districts established pursuant to this By-law, and any reference in this By-law to Schedules “A” to “I” inclusive shall be deemed to refer to the district or districts established herein and described by the Schedule referred to.

Residential Areas - **SCHEDULE A**

RA-1, RS-1, RS-1A, RS-1B, RS-2, RS-3, RS-3A, RS-4, RS-5, RS-6, RS-7, RT-1, RT-2, RT-3, RT-4, RT-4A, RT-4AN, RT-4N, RT-5, RT-5A, RT-5AN, RT-5N, RT-6, RT-7, RT-8, RT-9, RT-10 and RT-10N, RT-11 and RT-11N, RM-1 and RM-1N, RM-2, RM-3, RM-3A, RM-4, RM-4N, RM-7 and RM-7N, RM-8 and RM-8N, RM-9, RM-9A, RM-9N and RM-9AN, FM-1 (residential use portion), FSD Districts and all CD-1 Districts except as provided for in SCHEDULE E.

Commercial and Industrial Areas - **SCHEDULE B**

C-1, C-2, C-2B, C-2C, C-2C1, C-3A, C-5, C-6, C-7, C-8, DD, FC-1, FM-1 (commercial use portion), HA-3, MC-1 and MC-2, IC-1, IC-2, IC-3 and CWD Districts (collectively referred to as “Commercial Areas”).

M-1, M-1A, M1-B, M-2, I-1, I-2 and I-3 Districts (collectively referred to as “Industrial Areas”).

Chinatown and Gastown Historic Areas - **SCHEDULE C**

HA-1, HA-1A and HA-2 Districts.

West End Area - **SCHEDULE D**

RM-5, RM-5A, RM-5B, RM-5C and RM-6 Districts.

Comprehensive Development Areas - **SCHEDULE E**

FCCDD, DEOD, BCPED, and all CD-1 Districts listed therein.

Bridge and Freeway Areas - **SCHEDULE F**

The areas shown on Maps 2A, 2B, 2C and 2D.

Granville Street - Downtown (between Hastings Street and Granville Bridge) except for Schedule G2 Area - **SCHEDULE G1**

Granville Street - Northeast Corner of Granville and Robson Streets - **SCHEDULE G2**

The areas shown on Map 3.

CD-1 Number 311 (Rogers Arena) - **SCHEDULE H**

CD-1 Number 265 (International Villate A - Portion bounded by Pender, Taylor, Keefer and Abbott Streets) - **SCHEDULE I**

- 9.3** A commercial or industrial use located in a Residential Area, as specified in Section 9.2, and which is by reason of Section 568 of the Vancouver Charter a non-conforming use, shall be permitted to have any sign as if it were located in a C-1 district.
- 9.4** Where two or more schedules apply to any district or area, the more restrictive provision shall prevail, except that Schedule B shall not apply to sites regulated by Schedules G1 and G2.
